How PSTIF Can Work for You



PSTIF funding may be currently available
for
Your storage tank Site.

If you are the current or past owner of a property that has sustained a documented release from an underground or above ground storage tank (UST/AST) you may be eligible for funding for investigation and clean-up activities under the rules of the State of Missouri PSTIF.

Under current federal and state law, owners of USTs that store hazardous materials are liable for damages resulting from unexpected releases. Local and state agencies that provide oversight for environmental damages resulting from releases may require you to perform certain measures to investigate and cleanup environmental contamination resulting from these releases.

Missouri state law established the Missouri Petroleum Storage Tank Insurance Fund to assist tank owners with funding for cleanup operations required by regulating bodies

UST Release
